## 1. GENERAL INFORMATION

## 2. TERMS AND CONDITIONS FOR APPLICATION ON THE COURSE

- Minimum age of 18 years
- Payment receipt for course
- At the beginning of the training, the candidate must submit a personal document to prove his or her identity.

## **With Self-signed signature of application, the candidate confirms:**

1. That he or she is familiar and agrees with the entire content of the current call for Assistant canyoning guide course of Canyoning association of Slovenia, carried out by Canyoning association of Slovenia.
2. That he or she is aware that Assistant canyoning guide course, is a hazardous activity and that the candidate's participation on Assistant canyoning guide course is associated with a high level of risk, which means that injuries and ultimately death might occur during training.
3. That he or she shall strictly follow all instructions from the instructors to ensure that the highest level of safety is guaranteed.
4. That he or she is aware that due to the demanding level of the training, all the specified personal equipment must be brought to training, and this equipment must be in perfect condition; that he or she must be psychophysically well prepared, and that it is highly advisable to obtain as much experience as possible from the field of canyoning prior to training.
5. That he or she is aware, all the required exercises need to be completed in order to pass the course successfully, but he or she may always refuse to participate in an exercise for which he or she might not feel sufficiently competent. By refusing, he or she will withdraw from further participation on the course. In this case, the course provider will not return the money.
6. That he or she is aware that the instructors have the right to prohibit further cooperation on course of any candidate whom they consider to be a threat to practical exercises for himself or herself and possibly to other participants, including instructors. In this case, the course provider will not return the money.
7. That he or she is aware of the fact that during the time of the course, the Canyoning association of Slovenia does not provide any health or accident insurance or any other kind of insurance. The candidates must have their own accident and/or health insurance arranged.

## 7. REQUIRED EQUIPMENT

Required equipment is a prerequisite for participating in course. Instructors will check the equipment on the first day. If the candidate does not have the necessary equipment, he or she will have one day to replace it or provide adequate equipment; otherwise he or she will not be able to continue the course. In this case, Canyoning Association of Slovenia will not return the money.

In the list below are examples of appropriate equipment in brackets, however the candidate can bring any equipment as long as it has identical certificates as the example of the equipment below.

- Static rope length 50m and wide 10mm, A – class (for example: Kordas – Iris 10, Edelrid – Diver 10, Petzl – Club 10, itd.)
- Backpack for the rope
- Working harness (for example: Petzl – Avao Sit, Edelrid – Iguazu II, itd.)
- Lanyard with karabiners (for example: Petzl – Dual Connect Adjust)
- 6 HMS screw gate karabiners (for example: Petzl – William, Black Diamond – RockLock, itd.)
- 2 figures of eights (for example: Petzl – Huit, Edelrid – Bud, itd.)
- 1 Shunt (Petzl – Shunt)
- 1 system with HMS karabiners and Tibloc (Petzl – Tibloc)
- Sling length 120cm
- 1 prusik length 3m
- Knife for rope cutting (example: CRKT - Bear Claw, Edelrid – Rescue Canyoning Knife)
- Maillone Rapid (Petzl – Maillone Rapid N7)
- Neoprene suit with a hood
- Shoes (for example: Adidas – Hydro Lace, FiveTen – Canyonier)
- Diving mask
- Alpinistična čelada z CE certifikatom
- First aid with suitable water case (reanimation mask, 2x sam splint, material for bending, candles, warming foil, scissors)
- Telephone with proper water case
- Whistle
