INTERPRETATION OF TERMS AND ACRONYMS



NATIONAL PROGRAM IN THE REPUBLIC OF SLOVENIA: WILD WATER RESCUER - PROGRAM C (license C)

A valid C license is required when performing guide activity on wild waters in the Republic of Slovenia (rafting, canyoning, kayaking, etc.)

Acronym: WWR-C



ADMINISTRATION OF THE RS FOR CIVIL PROTECTION AND DISASTER RELIEF- URSZR

- The umbrella governmental organization in the Republic of Slovenia which is responsible for regulating the field of water rescue
- Slovenian acronym: URSZR (URSZR operates within the Ministry of Defense of the Republic of Slovenia)



DROWNING PREVENTION INSTITUTE - ZVU

- Official authorized provider of training for wild water rescuers (WWR-C) in the Republic of Slovenia
- Slovenian acronym: ZVU



SLOVENIAN RED CROSS - RKS

- An official organization that conducts first aid training in the Republic of Slovenia and issues certificates of competence for water rescuers (lifeguards)
- Slovenian acronym: RKS



DOCTOR SPECIALIST OF OCCUPATIONAL, TRAFFIC AND SPORTS MEDICINE

It conducts examinations and issues medical certificates for water rescuers (lifeguards)

YOU CAN CHOOSE A DOCTOR IN SLOVENIA BY YOURSELF

PROCEDURE FOR OBTAINING A LICENSE FOR A WHITE WATER RESCUERS UNDER PROGRAM C (WWR-C). The candidate must meet the following conditions:

1,

SUCCESSFULLY COMPLETE TRAINING FOR WWR-C

The training is provided by URSZR-authorized contractors (ZVU)

AND

SUCCESSFULLY PASS THE WWR-C EXAM

The exam is conducted by the URSZR

It is necessary to register for the exam at the same time as registering for the WWR-C training!

SOMETIME BEFORE THE EXAM OR IN EXCEPTIONAL CASES ALSO AFTER THE EXAM, THE CANDIDATE MUST OBTAIN:

MEDICAL CERTIFICATE FOR WATER RESCUERS

The examination is performed by a doctor specialist of occupational, tranffic and sports medicine.

LICENSE ISSURANCE (license issued by URSZR)

The license is issued to the candidate when he meets all the conditions and submits all the necessary documentation to the URSZR. The license is valid for 3 years and is counted from the day of successfully passing the WWR-C exam.

DOCUMENTATION:

- 1. certificate of appropriate education (at least vocational secondary school IV. level);
- 2. a digital photo of the candidate (like for documents) for the card;
- 3. RKS certificate of FA for water rescuers (lifeguards);
- 4. medical certificate for water rescuers (lifeguards)

WHAT YOU NEED TO KNOW TO APPLY FOR ZVU-WWR-C TRAINING

(Simultaneously with the application for ZVU-WWR-C training, it is necessary to apply for the WWR-C exam at the URSZR as well.)

APPLICATION CONDITIONS FOR THE TRAINING:

completed age 18 years

CONDITIONS FOR PARTICIPATION ON THE TRAINING:

- personally signed Application Form
- personally signed Consent for the processing and use of personal data
- registration fee paid before the training
- successfuly passed swimming test
- all mandatory personal equipment

CONDITIONS for SUCCESSFUL COMPLETION OF THE TRAINING:

- 100% PRESENCE
- POSITIVE OVERALL EVALUATION OF DAILY EVALUATIONS

THE SWIMMING TEST shall be performed on the day of the start of the WWR-C training

Standard:

200 m in a maximum of 4 minutes
25 m under water

MANDATORY PERSONAL EQUIPMENT:

White water clothing like 5 mm neoprene wetsuit with hood or drysuit and neoprene cap (we recommend wetsuit for easier swimming);

- •strong sports shoes with strong thick soles like running shoes, low trekking shoes or special canyoning shoes (sandals, light kayak shoes or neoprene booties for rafting with thin soles are strictly forbidden);
- neoprene socks if you are using wetsuit;
- •helmet (kayak or climbing helmet) with a piece of duct tape on the front side where the name of the participant is written;
- PFD (personal floating device or so-called life jacket) with a quick release system. You also need a cowtail with stainless steel ring on one end of the cowtail and big pear shaped (HMS) locking carabiner on the other end;
- white water knife with a folding or fixed blade;
- •a whistle that works in wet conditions;
- •throwbag with special carrying belt (the throwbag is carried around the waist), minimum length of rope is 20 m;
- •4 pear-shaped (HMS) carabiners with locking gate design and CE/UIAA certified. The best are those with a screwgate mechanism and key lock system;
- •8 m of 6 mm accessory cord (Prusic), cord should be CE/UIAA certified;
- •8 m of webbing tape, breaking strength minimum 15 kN and CE/UIAA certified;
- Nylon sling length of 170 to 180 cm (climbing anchor sling-loop) width min 1,5 cm and CE/UIAA certified;
- •3x AA batteries;
- •pen and notebook for theory notes.
